The Sandhills Community College & Club's Protocols are as follows: The test site is on College property and the club has special permission to be at this site. No training at this site is permitted without prior written approval of the Board of TWC. Violators will be subject to an Event committee hearing for endangering the Club's ability to hold events at this site. Please respect this area by cleaning up after your dog. Dogs must be on leash at all times.

General Tracking and Cautionary Disclaimers are as follows:

No dogs are to be allowed to be "off lead" – due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any area of the tracking site.

Cancellation of Event may occur due to extreme hazardous weather conditions as determined by the Tracking Committee and Judges.

LIMITATIONS ON ENTRIES

Entries will close Thursday, October 28, 2010 at 6:00PM. The draw will be conducted at 1526 Wildwood Dr., Oxford, NC 27565 on Thursday, October 28, 2010 at 8:00 p.m. Entries cannot be accepted, cancelled, substituted or altered after the stated closing date and time.

Entry is limited to AKC registered dogs at least six month of age or older. This Test is limited to (4) VST tracks. Preference in the drawing will be given as follows:

1. Weimaraners without VST titles
2. Weimaraners with VST titles
3. Other Breeds without VST titles
4. Other Breeds with VST titles

Entries must be made on an official American Kennel Club entry form, signed by the actual owner or duly authorized agent. Conditional, unsigned, telephone and telegraph entries cannot be accepted. There will be a \$20.00 fee imposed for returned checks. All entries must be paid in full prior to showing. Entries sent by overnight delivery service MUST include signature release.

Bitches in season may participate provided that the Test Secretary and Judges are notified that a bitch in season is present prior to the drawing for tracks. The last track shall be reserved for the bitch in season. If there is more than one bitch in season, a second draw for these bitches will be held.

Entries will be acknowledged, by phone and/or email and a judging program will be mailed as stated in the regulations. Should you have any questions please contact the Test Secretary, Helen Sanderford at helen.sanderford@gmail.com.

Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Test Committee or because it has been entered incorrectly.

No video taping of this event will be allowed without prior permission of the Test Secretary and the judges.

Successful teams will be awarded the end of track article, a cash award of \$25 and an appropriate memento. Trophies will not be mailed.

From US 1 going North:

Take the Exit labeled Midland Road, State Route 2 and 22 (there is also another sign that says Sandhills Community College). At the top of the ramp take a left and go about a tenth of a mile. There will be another Sandhills CC sign, and a sign for SR 22N. Take a right onto Central Drive (which is also SR22). Go approximately 2.6 miles and come to a traffic circle at the airport. Take the 3rd exit out of the circle labeled Pinehurst onto Airport road. Go about 0.8 miles and the college is on the left. The main entrance has a large rectangular concrete sign. The draw site is in the "Homer" parking lot, at the rear of the college, near the athletic fields.

From US 1 Going South:

Take the exit labeled Midland Road, State Route 2 and 22 and there is also another sign that says Sandhills Community College. At the top of the ramp, take a right and go less than 100 yards. You will see signs for Sandhills CC, and SR 22. Take a right onto Central Drive (which is also SR22). Go approximately 2.6 miles and come to a traffic circle at the airport. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
