Single course with bird field, using flight conditioned quail, judges on ATV/UTVs

TESTS, RUNNING, AND STARTING TIMES:

Master: Course A, 30 min – Test #1 not before 7:30am
Senior: Course A, 30 min – Test #2 to follow Test #1
Junior : Course B, 15 min - Test #1 not before 7:30am Test #2 to follow Test #1

Entry fees will not be returned for dogs withdrawn after closing, except for bitches in heat.
Entry fees also will not be returned if a test has to be halted due to circumstances beyond the control of the club, eg lightning or inclement weather.

LIMITED ENTRY:

Entries limited to the number of dogs which may be run in daylight hours. If that limit is reached, subsequent entries will be placed on a waiting list. Entries are not considered complete until payment is received.

Orange 3-streamer Rosettes for qualifying dogs
New Title ribbons for dogs finishing a title

DIRECTIONS TO THE TEST SITE:

From US-1 S in Sanford: Turn right onto US 15-S / US-501 S, and follow it for 17.3 miles. Turn right onto NC-73, and follow it for 7.5 miles. Turn left onto NC-211 / NC-73, and continue for .2 miles. Turn right onto NC-73 and continue for 4.5 miles. Turn right onto Jackson Springs Rd, and go for 1.3 miles. The grounds are on the right, 0.7 miles past Ivan Rd.

From US-220: Take the NC-73E exit, #16. Turn left onto NC-73E and continue for 6.5 miles. Turn left onto Jackson Springs Rd, and go for 1.3 miles. The grounds are on the right, 0.7 miles past Ivan Rd.

North Carolina law requires that everyone, age 16 and over, who attends this event have a hunting license (North Carolina or state of your residence) even if you don't carry a gun.

Lunch: *There will be a limited number of sandwiches/lunch available for purchase on the grounds. There are no eating establishments near the hunt test grounds, so make sure that you bring whatever you want to eat and/or drink.*
